**Restricted Classes** – Open to horse/rider combinations who have not previously been placed 1<sup>st</sup>-3<sup>rd</sup> in the same level of class prior to date of the competition being entered.

If entering Restricted section you may also enter Open section of same level

**Class 1** - May only enter classes 2 & 3 **Class 2** – May only enter classes 4 & 5

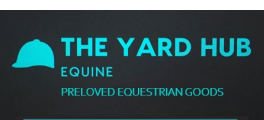
**Class 3** - May only enter classes 2 & 4

## Championships

**AEC Series Championship for all classes for both Juniors & Seniors**

For each competition, horse and rider combinations placed 1<sup>st</sup> to 6<sup>th</sup> will receive points : 1<sup>st</sup> - 8 / 2<sup>nd</sup> - 7 / 3<sup>rd</sup> - 5 / 4<sup>th</sup> - 4 / 5<sup>th</sup> - 3 / 6<sup>th</sup> - 2 (points will be reduced pro-rata if less than 6 in class)

**To qualify for championship, combinations must have competed in at least 3 competitions**

**Note:** those moving from Restricted to Open sections during the series will carry forward their restricted points to the Open championship. In the event of a tie on points, the number of classes entered, followed by % scores will be taken into account.

**Junior & Senior Champion and Reserve Champion** will receive Prizes in the form of gift vouchers to the value of £20 Champion & £10 Reserve presented at the final April competition
